SALES

20% commission will be charged on all sales. All commission proceeds will directly benefit art programming.

ENTRY FEES

- Jury fees are non-refundable: \$30 for artists that are AAEGV members and \$60 for non-members. All artists may exhibit up to 2 pieces. Sizes: work must be smaller than 30” on any side including the frame.
- To submit your entry online, you may go to www.elkgroveparks.org and click on Registration, log in, select tickets, find JAS. Jury fees may also be paid by cash or credit card at the Pavilion, Elk Grove Park District in person. Checks can be mailed, made payable to Elk Grove Park District.

*Your entry gives permission to use your artwork for promotional purposes.

ENTRY PROCEDURES

- Preferred entry method is by registering on the park district website. Send images with all entry form info to aaegvexhibits@gmail.com.
- Emailed entries will be notified of acceptance by email.

- Artwork must be original, conceived and executed solely by the artist.
- Art should have been completed within the last 2 years.
- Work completed in a classroom setting where all students paint the same paintings, do not qualify.
- Prices must remain as stated on the entry form.
- All work must be framed or gallery wrapped and ready for hanging. (please tape the ends of the wire on back of piece)

- All work must be for sale.
- Any work that has been exhibited in previous Artists' Association of Elk Grove Village juried shows or any artwork that has already received an award does not qualify for entry.

ELIGIBILITY

This juried exhibit is open to all fine artists, 18 years and older, living within a 50 mile radius of Elk Grove Vlg, IL.

We reserve the right to reject any art that does not meet our expectations or conforms to the norms of the community.
